Wisconsin Title II Formula Grant Program Racial and Ethnic Disparities (R/ED) Reduction Plan Kiley Komro reported the subcommittee will hear a presentation from Department of Children and Families (DCF) on the Youth Assessment and Screening Instrument (YASI) and then consider action steps for the Racial and Ethnic Disparities Reduction Plan.

YASI Summary

Shelby McCulley, DCF Bureau of Youth Services Director and Ragen Shapiro, DCF Youth Services Section Manager

McCulley and Shapiro used a power point to report on why DCF is implementing a statewide risk/need strength assessment instrument; where it is in the implementation process; and how it will help achieve better outcomes for Wisconsin youth. The presentation included information regarding how the YASI, if used with fidelity, mitigates bias, and may have positive impacts on racial and ethnic disparities in the juvenile justice system. The presenters explained that next steps for implementation could include educating decision makers, such as judges and District Attorneys, on the YASI assessment and case management system.

Komro reviewed Proposal #3 that was approved by the subcommittee on September 7, 2022. The Subcommittee began discussion on possible actions steps to implement Proposal 3. The steps were not finalized, and more work needs to be distributed among the subcommittee at future meetings.
