DOJ Updates

Grants

Kiley Komro reported that the GJJC grants workgroup has recommended approval of two Juvenile Deflection and Diversion grant awards. The awards are being reviewed by the DOJ front office and once that approval is done, Komro will notify the award recipients. Komro said the next grant announcement will most likely be posted in November and will be noncompetitive for a specific program.

Compliance

Allord reported the DOJ staff has started the compliance monitoring tasks. The JJDPA Annual Survey was sent to about 600 law enforcement agencies and compliance monitors are scheduling site visits. Allord gave a brief review of compliance practices and answered questions from subcommittee members.

Business

Wisconsin Disparity Data Factsheet

Komro reported the *Racial and Ethnic Disparities in Wisconsin's Juvenile Justice System* factsheet was updated and highlighted the new information and layout. Subcommittee members asked if Komro is aware of other states' diversion programs that reduce disparities and if so, suggested those programs be added to the fact sheet. Komro will research other states for those programs and reported the factsheet will be finalized at a future meeting in 2024.

Three-Year Planning: Reducing Racial and Ethnic Disparities Priority, Goals, and Objectives Komro used a power point to summarize the 2023 Racial and Ethnic Disparities (R/ED) Plan and information from the juvenile justice stakeholder survey that was completed in September. Komro used survey information to create the goals and objectives that were considered by the subcommittee for the 2024 Racial and Ethnic Disparities Plan.

Subcommittee members suggested local groups that would benefit from learning about R/ED Plan and data, and best practices in 2024. Some subcommittee members volunteered to partner with DOJ on delivering these presentations. DOJ staff will start a draft R/ED in Wisconsin presentation. Chair Pearson asked DOJ Staff if the Office of Juvenile Justice and Delinquency Prevention (OJJDP) makes racial and ethnic disparities presentations at states' conferences. DOJ said that OJJDP offers many webinars to juvenile justice stakeholders so they can be presenters at their own state's conferences. DOJ Staff will ask OJJDP if they are interested in presenting at state's conferences.

Chair Pearson requested that the Subcommittee incorporates Youth Voice Commission members and their feedback into Subcommittee activities. Komro highlighted GJJC Youth Members on the Subcommittee and the feedback from YVC meetings shared in the presentation.
