# **DOJ Updates**

<u>Grants</u> - Kiley Komro reported Your Move MKE was awarded the Implicit Bias and Disparity Reduction Grant. The grant award review process has started for the Indian Tribes Passthrough grant and the Positive Youth Development Program grant.

Komro reported the next round of grant announcements will be in 2025.

<u>Compliance</u> – Matt Allord reported DOJ Staff is planning for the compliance audits and will send out the Juvenile Justice Delinquency Prevention Act Annual Survey in October 2024. The compliance time period is October 1, 2023, to September 30, 2024.

<u>Staff</u> – Matt Allord introduced Jessica Reindl as the new Juvenile Justice Coordinator. Reindl will be a compliance monitor, do compliance audits and will be the Racial and Ethnic Disparities

# **Business**

# The Sentencing Project: Diversion and Best Practices – Dick Mendel

Mendel used a PowerPoint to discuss the benefits of diversion programs and why more programs will improve the juvenile justice system. Mendel described factors influencing disparities at the point of diversion. Subcommittee members were able to ask questions for more information.

# **Disparities Factsheet Distribution**

Komro reported the Racial and Ethnic Disparities (R/ED) Factsheet and a PowerPoint is available for Subcommittee members to use for outreach and presentations at meetings and conferences. These documents can be used with the RED Factsheet – WI Diversion and the RED Factsheet – WI Petition documents that were emailed with meeting documents.

Commissioner Pearson reported he is planning to present the R/ED Factsheet to Judge Mitchell's law school class at the UW – Madison Law School.

Subcommittee member Wendy Voz Daniels suggested presenting to the Milwaukee Community Justice Council and to contact Commissioner Carl Ashley who is also the Chief Judge in Milwaukee County to see if a presentation could be made at the Milwaukee County Race, Equity, and Procedural Justice Annual Conference in Spring 2025.

Subcommittee member Kim Jenkins reported she has shard the R/ED Factsheet internally at the Department of Public Instruction.

DOJ Bureau of Justice and Information Analysis Staff Kerrie Fanning suggested sharing the R/ED Factsheet with UW Extension because they have programming focused on families and youth involved in the justice system.

Wendy Volz Daniels suggested sharing with the Wisconsin Counties Association and the Wisconsin County Human Services Association.

Commissioner Muskadee Montano reported she will share with her local partners including local schools, tribal partners, and medical centers.
