### **Convene and Roll Call**

The Executive Subcommittee convened at 8:00 a.m. Quorum was present. Chair Sharlen Moore welcomed members to the meeting.

### **DOJ Updates**

#### **Grants**

Komro reported there are two non-competitive grant announcements posted on the GJJC website and the DOJ Grants website.

- 1. Youth Gang Diversion Balance of the State This funding opportunity is available to designated agencies for provide services "for the diversion of youths from gang activities into productive activities, including placement in appropriate educational, recreational, and employment programs." Programs must serve youth and are encouraged to target specific at-risk youth based on identified risk factors, rather than all youth in a community.
- 2. Youth Gang Diversion and AODA Prevention Milwaukee This funding opportunity is available to the Milwaukee Social Development Commission for provide services "for the diversion of youths from gang activities into productive activities, including placement in appropriate educational, recreational, and employment programs" and to support their programs designed to prevent and treat youth alcohol, and other drug abuse (AODA). The program must serve youth and are encouraged to target specific at-risk youth based on identified risk factors, rather than all youth in a community.

### Compliance

Sabrina Gentile reported Matt Allord and Jeff Sauer have completed the compliance site visits and are finishing reviewing the Annual Surveys hold information. Gentile said that once all the data is reviewed, Allord will summarize and present final compliance numbers to the GJJC. Chair Moore highlighted DOJ staff consistent oversight and partnership with local facilities. Gentile responded to Commissioner questions about high-hold facilities and the technical assistance DOJ provides to such facilities.

### Staff

Gentile reported DOJ Staff will begin reviewing the applications for the Juvenile Justice and Racial and Ethnic Disparities Coordinator. The application review and hiring process will take some time.

### Legislation

Gentile reported the Senate Judiciary and Public Safety Committee will hold a hearing on DOC Type 1 secured correctional facilities rule on Wednesday, April 10, 2024. Meeting information will be sent to the Executive Subcommittee and the Policy, Legislation and Compliance Subcommittee.

### **National Juvenile Justice Specialist Nomination Letter of Support**

Matt Allord reported Kiley Komro is applying to be the Coalition for Juvenile Justice (CJJ) – National Juvenile Justice Specialist. The CJJ position would organize monthly meetings, lead discussions among JJ Specialists, work with the CJJ in addition to other tasks. Allord sent a draft recommendation letter to the Executive Subcommittee to approve and add to Komro's
