#### **Welcome and Call Meeting to Order**

Chair Sharlen Moore welcomed commissioners to the meeting.

Chair Moore requested a motion to approve the August 8, 2023, GJJC Meeting Minutes.

#### **Motion to Approve Minutes**

#### **State Advisory Group 101 Training**

Kiley Komro and Matt Allord used a PowerPoint presentation to inform the Commission on the history of the Juvenile Justice and Delinquency and Prevention Act (JJDPA); the role of the Designated State Agency and State Advisory Group; and the Wisconsin Department of Justice's juvenile justice compliance monitoring policies and procedures. Komro and Allord answered questions from the Commission.

Komro used a PowerPoint presentation to lead a training and discussion on Robert's Rules of Order, meeting etiquette and community agreements. Commission members participated in the training and shared ideas for more engaged and effective meetings.

# Three-Year Strategic Planning Data Presentation

Komro used a PowerPoint presentation to inform the Commission on the juvenile justice stakeholder survey results; youth risk behavior data; and arrest data. Carlton Frost, Department of Children and Families, provided information regarding the youth justice referral data and answered questions from the Commission.

The presentation highlighted stakeholder reported needs for more service providers, especially mental health professionals. Commissioner Chapin and others discussed the lack of service providers and interventions for youth including licensing delays for prospective providers working with Wisconsin Division of Safety and Professional Services (DSPS), with some improvement recently.

# Three-Year Strategic Planning continued Subcommittee Sharing

<u>Youth Voice Commission (YVC)</u> – Commissioner Abigail Gosetti, Commissioner JP Rotatori and Commissioner Kenna Tripple reported on YVC activities. The youth Commissioners shared YVC's vision for the YVC including how it can educate young people about the justice system and life skills. The Commissioners described the goals and funding priorities set by YVC members and discussed current projects.

<u>Policy, Legislation and Compliance (PLC) Subcommittee</u> – Commissioner Diane Rondini, reported the GJJC re-affirmed statement to return 17-year-olds to the juvenile justice system was distributed to the legislature and the Governor. The *Raise the Age Coalition* has shared a bill draft and hopes the bill draft is circulated in the legislature for co-sponsorship soon.

The subcommittee has a goal of addressing per-minute fees for phone use by youth in some of the juvenile detention centers across the state. The Commission discussed strategies moving forward and Commissioners Hermes and Pearson gave their input as staff overseeing detention or correctional facilities. DOJ will work with the subcommittee and Commissioner Pearson on potential paths forward to better understanding the costs and strategies to eliminate phone call fees in juvenile detention centers.

The Commission drafted and shared a letter with the legislature supporting AB 48 and SB 55 relating to prosecuting or adjudicating delinquent a person under the age of 18 for committing

an act of prostitution. After a public hearing in June of this year there has been no further legislative movement of note.

<u>Ethnic and Racial Disparities (ERD) Subcommittee</u> – Commissioner Moore and Commissioner Edjron Pearson reported the ERD Subcommittee is developing a *Racial and Ethnic Disparities in Wisconsin Fact Sheet*. Commissioner Moore hopes the subcommittee will have a final document early in the new year.

### **Priorities, Goals and Objectives**

The Commission split into two groups to create a list of priorities for the three-year plan and Title II Formula Grant. After much discussion, the two groups prioritized mental health services and delinquency prevention services with a strong preference for family-based and early intervention programs. The Commissioners placed additional emphasis on streamlining the grant process to ensure smaller subgrantees have ample opportunity to apply, and applicants are encouraged to incorporate local level data, planning and racial and ethnic disparity reduction into their applications.

The priorities discussed during the meeting will be incorporated into the 2024-2026 Three-year Plan and Title II Formula Grant application.

#### Wisconsin Department of Corrections (DOC) Updates

Commissioner Ron Hermes reported Lincoln Hills and Copper Lake Schools are in substantial compliance with 36 of the 50 recommendations in the consent decree according to the last Monitor's Report. Hermes reported the staff vacancy rate is at 10%. Last year at this time the vacancy rate was at 47%. The population on November 14 was 45 boys and 6 girls, although 6 more boys were arriving today.

Commissioner Hermes invited the Commissioners on the YVC to Lincoln Hills School for a tour and potentially meet with some of the youth.
