Convene and Roll Call

DOJ Updates

Staff

There were no staff updates.

Compliance

Matt Allord reported he and Jess Reindl have been auditing law enforcement agencies. Allord trained Reindl at the start of the audit season and now Reindl is auditing agencies on her own. Allord reported the audits should be completed in about a month or so.

Legislation

Sabrina Gentile reported the 2025-2026 Legislative Session began on January 6, 2025. 99 State Representatives and 16 State Senators were sworn in.

The Legislative Council Study Committee on Emergency Detention and Civil Commitment of Minors committee will meet in January or February. At this meeting, they will vote to recommend legislation to be considered in the 2025-2026 Legislative Session.

Governor Evers will deliver his State of the State address on January 22, 2025, and his state budget address on February 18, 2025.

Grants

Kiley Komro reported there are two grant opportunities posted the DOJ Grants website.

- 1. OJJDP PREA Reallocation Funds This is a pass through, non-competitive grant for the Wisconsin Department of Corrections (DOC) for reallocation funds to support compliance with the U.S. Department of Justice (US DOJ) National Standards to Prevent, Detect, and Respond to Prison Rape.
- 2. JJ Formula: School-Based Restorative Justice Programs This competitive funding opportunity aims to improve youth's school connectedness, reduce formal justice system involvement for school-related incidents, and reduce ethnic and racial disparities in school discipline and referrals. The funding will support school districts in reducing the use of exclusionary school discipline practices; reduce future harmful, disruptive, or delinquent behavior of students; and support accountability and reintegration of students into their classrooms and schools.

Komro reported the Bureau of Justice Programs – Juvenile Justice Section is the recipient of the FY24 Improving Adult and Youth Crisis Stabilization and Community Reentry Program grant award. The funding will be used to implement mental health and substance use disorder screenings, assessments, and services for youth in juvenile detention centers. The funding will help coordinate treatment for youth while they are in the facility and upon reentry into the community.

Subcommittee members congratulated Komro and staff and suggested policies and programs to support with the grant award.

Chair Diane Rondini asked for a motion to approve the October 8, 2024, Executive Subcommittee Meeting Minutes.
